COMES NOW Missouri-American Water Company (“MAWC” or the “Company”), and, in order to supplement the Joint Application, states as follows to the Missouri Public Service Commission (“Commission”):

1. On January 5, 2004, MAWC and Cedar Hill Utility Company, Inc. (“Cedar Hill”) filed a Joint Application seeking authority for MAWC to purchase the Cedar Hill sewer system. After the issuance of the Commission’s Protective Order, the applicants filed The Contract For Sale of Sanitary Sewer System Assets (the “Contract”) with the Commission on January 15, 2004.


