The tap fee is based on the average of the Utility's actual cost for materials and labor for standard residential connection plus road bores and other extraordinary cost.

Total Cost to Connect to Sewer	\$905.00
COMMERCIAL CONNECTION FEE	Actual Cost
RECONNECTION FEE	
The reconnection fee will be charged before service can be restored to a customer who has been disconnected for the following reasons:	
a) Non Payment of bill (Maximum \$25.00)	\$25.00
b) Customer's request	\$45.00
TRANSFER FEE	\$45.00
The transfer fee will be charged for changing an account name at the same service location where the service is not disconnected.	
LATE CHARGE	Greater of \$2.00 or 5%
A one-time penalty may be made on delinquent bills but may not be applied to any balance to which the penalty was applied in a previous billing.
