RESPONSE OF THE SHOW ME CONCERNED LANDOWNERS TO  
RECOMMENDATIONS FROM GRAIN BELT EXPRESS AND STAFF'S RESPONSE  
REGARDING PROCEDURAL SCHEDULE

Show Me Concerned Landowners (Show Me) respectfully submits the following response to Grain Belt Express's "Recommendations Regarding Procedure to Address Information Filed by Grain Belt Express Clean Line LLC" (GBE), and "Staff's Response to Order," both filed on April 22, 2015.

Show Me supports the "Response of the Missouri Landowners Alliance To Recommendations From Grain Belt Regarding Procedural Schedule," (MLA), filed on April 24, 2015. Like the MLA, Show Me believes that GBE's recommendations for phase 2 of this case should be rejected for several reasons, not the least of which is that the statutes and Commission rules governing contested cases require the full panoply of procedural tools be made available to the parties if the Commission wants to consider receiving additional evidence into the record of this case. And, also like MLA, Show Me would want to avail itself of the opportunity for discovery, the filing of rebuttal and surrebuttal testimony, cross-examination of witnesses, and post-hearing briefing.

Show Me also supports the "Staff's Response to Order," filed on April 22, 2015, in which Staff recommends to the Commission that it cancel the 30-day deadline for

responses to the information filed by Grain Belt on April 13, 2015, and set an on-the-record procedural conference as soon as possible for the hearing officer presiding over this case to work out a supplemental procedural schedule.
