On July 18, 2017, 188 North Summit, LLC and Seges Partners Mobile Home Park, LLC ("Applicants") filed a joint application with the Missouri Public Service Commission ("Commission") seeking authority for 188 North Summit, LLC to purchase substantially all of the water and sewer assets of Seges Partners Mobile Home Park, LLC. On August 25, 2017, the Staff of the Commission filed a recommendation to approve the application subject to several conditions. The Commission will direct the Applicants to file a response addressing the conditions in the Staff recommendation and provide an opportunity for any other party to object or comment on the proposed conditions.

**THE COMMISSION ORDERS THAT:**

1. 188 North Summit, LLC and Seges Partners Mobile Home Park, LLC shall respond to the Staff recommendation, specifically addressing the conditions set out therein, no later than September 6, 2017.
2. Any other party wishing to respond to the proposed conditions in the Staff recommendation shall do so no later than September 6, 2017.
3. This order shall be effective when issued.
