STATEMENT OF CEDAR HILL UTILITY COMPANY IN SUPPORT OF MISSOURI-AMERICAN WATER COMPANY'S PROPOSAL CONCERNING ACQUISITION <u>PREMIUM</u>

Comes now Applicant Cedar Hill Utility Company ("Cedar Hill"), by its undersigned counsel, and expresses its support for the proposal of Missouri-American Water Company ("Missouri-American) to postpone any decision concerning the treatment of any acquisition premium until the Commission deals with Missouri-American's next rate case proposal. In support of this statement, Cedar Hill states the following:

1. On May 17, 2004, Missouri-American responded to Staff's proposal that, <u>inter</u> <u>alia</u>, suggested that the Commission should condition approval of the proposed acquisition on Missouri-American's agreement not to seek recovery of any acquisition premium in its rates. Missouri-American noted that in the context of the acquisition and this Case, it is making no proposal to increase rates to recover the premium, distinguishing this Case from the situation presented in <u>State ex rel. Ag Processing, Inc. v. Public Service Commission</u>, 120 S.W.3d 732 (Mo. 2003). Missouri-American suggests that it is premature to consider Staff's proposal, and indicates that it would be willing to deal with the issue in the context of its next rate case.

2. Cedar Hill agrees with and supports Missouri-American's proposal. The proposal is a sensible solution to the issue which Staff feels must be decided, at some point: whether and to what extent the acquisition premium may be included in the rate base. As Missouri-American

is not proposing to include the acquisition premium in the rate base at this time, Staff's proposal presents an academic and hypothetical question. Given the Commission's limited resources, it should decide this question at the appropriate time, which is not in the context of this Case.
