ORDER SETTING PREHEARING CONFERENCE

On October 19, 1999, Utilicorp United Inc. (Utilicorp) and St. Joseph Light & Power Company (SJLP) filed a joint application for authority to merge SJLP with and into Utilicorp. On November 17, the Commission issued an order that granted the applications for intervention filed by AG Processing Inc., the City of Springfield, through the Board of Public Utilities, Union Electric Company, d/b/a AmerenUE, and the Missouri Department of Natural Resources.

Along with their Application, UtiliCorp and SJLP filed a Motion to Establish Procedural Schedule. In their motion, UtiliCorp and SJLP set forth a detailed proposed procedural schedule. On October 26, the Commission notified the parties that it would allow the parties until ten days following the deadline for filing of requests for intervention to file responses to the proposed procedural schedule. That means that those responses will be due on November 25. It now appears that a prehearing conference may be needed to assist the parties and the Commission in establishing an equitable procedural schedule. The

prehearing conference will also permit the parties to discuss any other procedural, discovery or substantive issues that may be in dispute.

IT IS THEREFORE ORDERED:

- 1. That an early prehearing conference shall be held on December 6, 1999, beginning at 10:00 a.m. The prehearing conference shall be held at the Commission's offices on the fifth floor of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri. - That this order shall become effective on December 2,
 1999.
