ORDER APPROVING TARIFF

Effective Date: May 12, 2010

The Missouri Public Service Commission is approving the tariff to which the Commission assigned tracking no. YW-2010-0603 ("tariff").

On November 20, 2010, SK&M Water and Sewer Company ("the utility") filed a request for a rate increase under the Commission's small company rate procedure. The utility filed the tariff on April 13, 2010. On April 14, 2010, the Commission issued its order approving a unanimous disposition agreement (agreement) that included an example of the tariff. The Commission's staff ("Staff") filed its verified *Staff Support of Tariffs* on April 21, 2010, and a correction to that filing on April 26, 2010, recommending that the Commission approve the tariff to become effective on May 13, 2010.

The Commission has examined the verified documents on file. The Commission independently finds and concludes that the tariff support safe and adequate service, at just and reasonable rates, and is in the public interest. Therefore, the Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff to which the Commission assigned tracking no. YW-2010-0603 is approved to become effective on May 13, 2010.
