ELEVENTH STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its Eleventh Status Report states the following to the Missouri Public Service Commission ("Commission"):

1. After the Staff had filed a Status Report on May 9, 2006¹, the Commission issued its ORDER DIRECTING STAFF TO FILE STATUS REPORTS ("Order") on May 12th, in which it ordered the Staff to submit monthly status reports on or before the 15th of each month until such time as a recommendation can be filed, or unless otherwise ordered by the Commission.

2. In compliance with the Commission's Order, the Staff submitted its Second Status Report on June 15th, its Third Status Report on July 12th, its Fourth Status Report on August 15th, its Fifth Status Report on September 15th, and its Sixth Status Report on October 12th, its Seventh Status Report on November 15th, its Eighth Status Report on December 15th, and its Ninth Status Report on January 12th, 2007, and its Tenth Status Report on February 15th, 2007.

3. For this Eleventh Status Report, the Staff reports that board of Public Water Supply District No. 1 of Lincoln County (the District) has accepted an engineering planning report, and is commencing negotiations with the owners of Lincoln County Utilities Co. with regard to some modifications to the sale contract. The modifications would include extending some specified dates,

and addressing a video inspection of the collecting sewers either to be conducted by Lincoln County Utilities Co. or with authorization for the District to enter and conduct such an inspection. The District is in the process of providing the Staff with a copy of the engineering report.
