ORDER CANCELING CERTIFICATES

On September 19, 2017, the Commission issued an order approving the joint application of 188 North Summit, LLC (“188NS”) and Seges Partners Mobile Home Park, LLC (“Seges”) seeking authority for 188NS to purchase substantially all of the water and sewer assets of Seges. The Commission also granted certificates of convenience and necessity to 188NS to provide water and sewer service within Seges’ authorized service area. As part of its order, the Commission directed 188NS or Seges to file a notice indicating when the closing on the transfer of assets was complete. 188NS filed notice on October 3, 2017, indicating that the transfer was completed on October 3, 2017. Because of the transfer, Seges is no longer providing water or sewer service in its certificated service territory. As provided in the order issued on September 19, 2017, the Commission will now

cancel Seges' certificates of convenience and necessity to provide water and sewer service.

THE COMMISSION ORDERS THAT:

1. Seges Partners Mobile Home Park, LLC's Certificate of Convenience and Necessity to provide sewer service is canceled.
2. Seges Partners Mobile Home Park, LLC's Certificate of Convenience and Necessity to provide water service is canceled.
3. This order shall be effective when issued.
