SNG’S RESPONSE TO STAFF RECOMMENDATION TO APPROVE

COMES NOW Summit Natural Gas of Missouri, Inc. (“SNG” or “Company”), and, in response to the Staff Recommendation to Approve Partial Waiver of 4 CSR 240-3.235, respectfully states as follows to the Missouri Public Service Commission (“Commission”).


1. On August 20, 2013, the Staff of the Commission (“Staff”) filed its Staff Recommendation to Approve Partial Waiver of 4 CSR 240-3.235 (“Staff Recommendation”). Therein, the Staff recommended that the Commission approve a partial, temporary waiver of Commission Rule 4 CSR 240-3.235, subject to certain listed conditions.

2. SNG has reviewed the Staff Recommendation and the proposed conditions and hereby states that it has no objection to the Staff Recommendation or the listed conditions. Accordingly, SNG requests that the Commission issue an order granting SNG a partial waiver of Commission Rule 4 CSR 240-3.235, subject to those conditions.

WHEREFORE, SNG respectfully moves the Commission to grant the Company a partial waiver from the requirements of Commission Rule 4 CSR 240-3.235 in regard

to its next general rate case, as described by the Staff Recommendation.
