In support of this filing, Liberty Utilities respectfully states as follows:

1. On October 24, 2018, the Commission issued its **Report and Order** in this docket (*"Order"*) in which directed the Company to provide information required by Section 393.275.1 and 4 CSR 240-10.060 by November 8, 2018.

2. Section 393.275.1 RSMo (2016) requires the Commission, *inter alia*, to notify the governing body of each city or county imposing a business license tax on gross receipts of any water corporation of any approved rate increase for that water corporation that exceeds seven percent.

3. The Company is providing the information referenced in the Section 393.275.1, RSMo 2016 and 4 CSR 240-10.060. **Appendix A** contains the list (with mailing addresses) of the cities in which Liberty Utilities does business that impose a business license tax or similar tax upon its gross receipts (there are no applicable counties) which will receive an increase of seven percent (7%) or more as a result of this case. **Appendix B** sets forth the estimate of the annual increase in gross receipts resulting from the rate increase on customers residing in such city and an explanation of the method used in developing the estimate. WHEREFORE, Liberty Utilities respectfully submits its compliance filing.
