- 1. On May 25, 2006, the Commission issued its Order to Show Cause.
- 2. The Order to Show Cause directed each Missouri natural gas local distribution company (LDC) to file a response on or before June 30, 2006, stating why it should not be required to file a claim seeking distribution from a settlement reached in the class action litigation currently pending in the Southern District of New York regarding NYMEX natural gas futures and options contracts.
