COMES NOW Nucor Steel Sedalia, LLC ("Nucor"), pursuant to 20 CSR 4240-2.075 of the Missouri Public Service Commission's Rules of Practice and Procedure and this Commission's January 12, 2022 *Order Giving Notice, Setting a Deadline to Intervene, Setting a Deadline to Response to the Test year, and Directing a Proposed Schedule*, and for its Application to Intervene respectfully states as follows:

- 1. On January 7, 2022, Evergy Missouri West ("Evergy") filed proposed tariffs and testimony in support a general rate case proceeding seeking an increase in its electric rates.
- 2. Nucor owns a steel production facility in Sedalia, Missouri. Nucor takes electric service from Evergy pursuant to a special contract. Nucor uses electricity throughout its operations, but in particular, Nucor uses substantial quantities of electricity to melt steel scrap, recycling it to make new steel. The cost of electricity is critical to Nucor's competitiveness in the national and international steel markets. As such, the outcome of this proceeding may have an effect on Nucor's cost of electricity.
- 4. Nucor's intervention will serve the public interest by assisting the record for the Commission's decision in this case. Nucor continues to review Evergy's request, and at this time, Nucor is unsure of the positions it will take.
