RESPONSE OF AMEREN MISSOURI AS REQUIRED BY MISSOURI PUBLIC SERVICE COMMISSION ORDER

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or Company), and states as follows:

- 1. On June 27, 2011, the Staff of the Missouri Public Service Commission (Staff) filed its *Motion to Reject or Suspend Tariff Filings (Staff Motion*).
- 2. On June 28, 2011, the Missouri Public Service Commission (Commission) issued its *Order Directing Responses to the Staff of the Commission's Motion to Reject or Suspend Tariff (Order)*. The *Order* requires Ameren Missouri to file its response to Staff's Motion by 3:00 p.m. on June 29, 2011. After the *Order* was issued, Ameren Missouri received service of Staff's *Motion*, 24 hours after it had been filed. Additionally, the Office of the Public Counsel (OPC) filed its *Public Counsel's Motion to Reject Tariff Filing and Response in Support of the Staff's Motion to Reject or Suspend (OPC Motion).*
- 3. Ameren Missouri disagrees with the majority of assertions and legal interpretations contained within both the *Staff Motion* and the *OPC Motion*. However, the Company does not believe it is possible for Ameren Missouri to provide the

Commission with a complete response to Staff's (and now OPC's) motions in the less

than 30 hours it was provided by the Commission's Order.

4. Two of the Ameren Missouri employees that are directly responsible for

its natural gas energy efficiency programs are on vacation until July 5, 2011. That,

coupled with the delayed service, makes filing a complete response by 3:00 p.m. today

impossible.

5. Ameren Missouri does recognize the Commission is under a time

constraint as the tariff will become effective on July 8, 2011, absent Commission action.

Ameren Missouri requests the Commission order a short suspension so that the Company

may have the normal 10 days to file a complete response. The Company would propose

suspending the tariff until July 14, 2011 and allowing Ameren Missouri until July 8, 2011

to file its response.² The Commission may then make an informed determination of

whether or not a longer suspension is justified.

WHEREFORE, Ameren Missouri files this pleading in response to the Missouri

Public Service Commission's *Order*, requests the Commission allow it until July 8, 2011

to file its complete response and suspend the tariff at issue in this case until July 14,

2011.
