## MOTION FOR EXPEDITED TREATMENT

COMES NOW Lincoln County Sewer & Water, LLC. (LCSW), and, in accordance with Missouri Public Service Commission (Commission) Rules 4 CSR 240-2.080(14) and 4 CSR 240-2.065(2), moves the Commission for expedited treatment of LCSW's

water and sewer tariff sheets filed on July 11, 2012:

1. On June 27, 2012, the Commission issued its Order Approving

Unanimous Stipulation and Agreement, Approving Transfer of Assets and Granting Certificates of Convenience and Necessity. Among other things, the Commission directed in that Order that LCSW submit its tariff sheets.

2. Concurrently with the filing of this Motion, LCSW filed a complete tariff to govern its provision of sewer service (<u>YS-2013-0031</u>) and a complete tariff to govern its provision of water service (<u>YW-2012-0032</u>). These tariff filings carried a proposed

effective date of August 10, 2012 (30 days). The basis for the tariffs was the Commission Staff's model tariffs and discussions with the Staff of the Commission.

3. LCSW seeks the Commission's order allowing the proposed tariff sheets to go into effect on July 20, 2012.

4. The certificated area encompasses two existing developments (Rockport and Bennington). The subject sewer and water systems have already been constructed and are in operation. Now that the certificates have been approved, LCSW should be allowed to move forward as a regulated utility at the earliest convenience.

 The subject tariff sheets and this Motion have been filed as soon as possible after the issuance of the Commission's Order Approving Unanimous
Stipulation and Agreement, Approving Transfer of Assets and Granting Certificates of Convenience and Necessity.

WHEREFORE, for the foregoing reasons, LCSW respectfully requests the Commission to grant LCSW's Motion for Expedited Treatment and approve LCSW's proposed tariffs (YS-2013-0031) and (YW-2013-0032) effective July 20, 2012.
