RESPONSE TO MOTION FOR EXTENSION

Come Now the Joint Applicants, Capital Utilities, Inc., Riverside Utility Company, Inc., Foxfire Utility Company, Inc., and AquaSource, Inc., through its whollyowned subsidiary AquaSource Utility, Inc., and for their Response to Motion for Extension respectfully state as follows:

1. On December 18, 1998, Staff filed a Motion for Extension ("Motion") in this case by which Staff sought an Order from the Commission extending the due date for Staff's recommendation herein to January 31, 1999; by Order dated December 9, 1998, the Commission had ordered Staff to file its recommendation no later than December 22, 1998.¹

2. The reason given by Staff in its Motion for its requested extension is that Staff has identified a need for additional information; the Joint Applicants would note that although the Joint Application was filed on November 25, 1998, Staff did not request any additional information from the Joint Applicants until December 17, 1998 – the day before Staff filed its Motion, only five days before its recommendation was due and more

than three weeks after the Joint Application was filed. Joint Applicants would also note that the length of the requested extension (December 22 to January 31) is longer than the length of time originally given to Staff to prepare and file its recommendation in the Commission's Order of December 9, 1998 (December 9 to December 22).

3. In its Order of December 9, 1998, the Commission recognized Joint Applicants' request for expedited approval of their Joint Application on or before December 31, 1998. Joint Applicants still wish to conclude the transactions contemplated in the Joint Application as expeditiously as possible, and will use their best efforts to respond to the information request received from Staff on December 17, 1998, as quickly as possible; Joint Applicants will endeavor to provide the requested information before the end of the year, which would be less than two weeks from the receipt of Staff's request when consideration is given to the intervening holiday. This should allow Staff sufficient time to review the information and file their recommendation by January 18, 1999, rather than needlessly prolonging the recommendation until January 31, 1999.

WHEREFORE, Joint Applicants respectfully request that the Commission extend the due date for the filing of Staff's recommendation herein to no later than January 18, 1999.
