RESPONSE OF STAFF TO ORDER DIRECTING RESPONSE

COMES NOW the Staff of the Missouri Public Service Commission and for its Response to the Commission's Order Directing Response issued October 28, 1999, respectfully states:

- 1. On October 12, 1999, UtiliCorp United Inc. ("UtiliCorp"), a Delaware Corporation conducting business in Missouri subject to the jurisdiction of the Missouri Public Service Commission, pursuant to § 393.190, RSMo. 1994 and 4 CSR 240-2.060(9), filed its Application seeking authorization from the Commission for it to acquire the remaining capital stock of Horizon Energy Distribution Limited ("Horizon") f/k/a Bay of Plenty Electricity Limited.
- 2. UtiliCorp requested the Commission approve its application by December 15, 1999.
- 3. In its application UtiliCorp states that it presently owns 78.8% of UnitedNetworks Limited ("UnitedNetworks") f/k/a Power New Zealand Limited and that UnitedNetworks owns approximately 52.3% of the voting securities of Horizon; however, those voting rights are limited by a shareholders' agreement.

- 4. In its application UtiliCorp indicates that it anticipates the direct acquisition of the remaining capital stock of Horizon will be made by UnitedNetworks or its nominee.
- 5. On October 28, 1999, the Commission issued its Order effective October 28, 1999, directing the Staff of the Missouri Public Service Commission ("Staff") and any other interested party to respond to UtiliCorp's request for expedited treatment no later than November 10, 1999 and for the Staff "to advise the Commission of the earliest date it could file a recommendation regarding the application."
- 6. The Staff requires additional information from the applicant regarding the proposed transaction in order to prepare its recommendation to the Commission regarding the application. Because the acquisition of the needed additional information is dependent upon the applicant, the Staff cannot determine the earliest date it can make its recommendation to the Commission regarding the application; however, if it receives the information it requires in a timely fashion, the Staff anticipates it will be in a position to file its recommendation to the Commission regarding the application no later than Friday, December 3, 1999.

WHEREFORE, the Staff does not oppose the request of UtiliCorp United Inc. for expedited treatment of the application filed in this case.
