RESPONSE TO ORDER DIRECTING FILING

Comes now **UNITED WAY OF GREATER ST. LOUIS, INC.** (hereinafter “UWGSL” or “Applicant”), and provides this response to the Commission’s Order Directing Filing dated May 3, 2007:

1. The Commission issued its Order Directing Filing as a result of UWGSL’s revision to Exhibit 7 of the application. Exhibit 7 listed the telephone exchanges in which UWGSL proposed to offer Information and Referral services, and Exhibit 7, as amended, removed certain exchanges from the original list and added others. The Commission raised the question whether any of the added exchanges were located in counties which had not received the notice issued by the Commission pursuant to 4 CSR 240-32.200 (4). The Commission then directed UWGSL to provide a statement of assurance that notice to all affected counties had been made.

2. In providing this response UWGSL assumes that the Data Center issued the required notice to the counties listed in Paragraph 26 of the Application. Based upon review today, UWGSL has determined that each exchange listed on Exhibit 7, as amended, is located within a county identified in paragraph 26 of the Application, and therefore all counties to which notice was required have been issued notice.

WHEREFORE, UWGSL prays the Commission accept the above and foregoing as the statement of assurance required by its Order Directing Filing.
