9	Q.	Please state your name and business address.		
10	A.	Darrell Cotton. 1901 Chouteau Avenue, St. Louis, Missouri 63103.		
11	Q.	Please state your occupation and by whom you are employed.		
12	A.	I am a troubleman for AmerenUE.		
13	Q.	Please summarize your work experience for AmerenUE.		
14	A.	I have worked for AmerenUE for about fourteen years. My initial jobs for		
15	AmerenUE were as a laborer and janitor and working in the storeroom. I became a lineman			
16	about eight years ago and I became a troubleman about two years ago, in 2000.			
17	Q.	On whose behalf are you appearing in this proceeding?		
18	A.	AmerenUE.		
19	Q.	What is the purpose of your Rebuttal Testimony in this proceeding?		
20	A.	I am going to testify about what I did at Sterling's Market in April 2001 to		
21	disconnect electricity there.			
22	Q.	What was your position with AmerenUE in the spring of 2001?		
23	A.	Troubleman.		
24	Q.	What were your duties at that time?		

- 1 A. Basically to handle various types of trouble calls, such as light out calls and wire
- down calls. I also disconnect and reconnect service as a troubleman.
- Q. Are you familiar with the grocery store which was located in the spring of
- 4 2001 at 8350 North Broadway in the City of St. Louis and known as Sterling's Market?
- 5 A. Yes.
- 6 Q. How are you familiar with Sterling's Market?
- A. I disconnected electric service to the store on April 17, 2001. 1 had also been in
- the store a few times so I was familiar with it before then.
- 9 Q. How was it that you disconnected power to the store on April 17?
- 10 A. Sometime around noon that day, I received a radio call from the dispatcher
- 11 ordering me to disconnect service.
- O. What time did you arrive at the store?
- 13 A. Around 1:00, after I finished lunch.
- 14 Q. What did you do when you arrived at the store?
- 15 A. I went into the store and told one of the clerks that I was from AmerenUE and I
- was there to disconnect the electricity. I was taken to an office in the back of the store where
- there were two men, one black and one white.
- Q. What happened next?
- 19 A. The black man introduced himself as Sterling Moody. When I told him why I
- was there, Mr. Moody thanked me for telling him that. He said he was waiting on a call from
- Jefferson City about getting some money to pay the bill. He asked me if I could hold off
- disconnecting service for awhile.
- Q. Did you delay cutting the electricity in response to his request?

1 A. Yes. 2 How long? O. 3 About thirty minutes or so. A. 4 What did you do during that thirty minutes? 0. 5 A. I spent some of the time in the office and some of the time out by my truck. What happened at the end of the thirty minutes? 6 Q. 7 I went back into the store and back to the office and told Mr. Moody I was going A. 8 to have to cut the service. 9 Q. How did Mr. Moody respond? 10 He asked me to give him a few more minutes to clear the store and shut down his A. 11 compressors. 12 Q. What did you do? I called my dispatcher to tell him that Mr. Moody wanted some more time. 13 A. Did you give Mr. Moody more time? 14 Q.15 A. Yes, I waited another forty five minutes or so. What did you do during this forty five minutes? Q. 16 A. I spent most of the time in my truck which I had parked behind the store. 17 What did you do when the forty five minutes were up? 18 Q. 19 I went back into the office through a rear entrance to the store and told Mr. A. 20 Moody I could not wait any longer, especially since my shift was close to ending. 21 Q. What did Mr. Moody say? 22 A. He told me to do what I had to do.

What did you do then?

I	A.	I disconnected service to the meter behind the store.	
2	Q.	What did you do after disconnecting the service?	
3	A.	I left in my truck.	
4	Q.	About what time did you leave?	
5	A.	Around 2:30.	
6	Q.	So how much time passed between the time you arrived at the store to	
7	disconnect the electricity and the time that you actually disconnected it?		
8	A.	About ninety minutes.	
9	Q.	Can you identify Schedule 1 to your testimony?	
10	A.	Schedule 1 is a 62 screen, like a work order.	
11	Q.	What is a 62 screen?	
12	A.	A 62 screen is usually prepared by a dispatcher to show what needs to be done on	
13	a job. The field workers fill out the rest of the screen on the computer to show what they did at		
14	the job.		
15	Q.	What does Schedule 1 show for Sterling's Market on April 17?	
16	A.	It shows Curtis Tunstall, a meterman, was at the store before I was that morning.	
17	It also shows when the computer has me dispatched there, what I did and when I logged out.		
18	The disconnection I did is shown where it says "open primary switches" and the "DC"		
19	completed.		
20	Q.	Does this conclude your rebuttal testimony?	
21	A.	Yes.
