<b>Subject</b>	<b>Responsible Agency(ies)</b>	<b>ATXI Action</b>
Threatened and Endangered Species / Conservation and Natural areas	Missouri Department of Conservation (MDC)	ATXI has coordinated with Missouri Department of Conservation on protected species, conservation opportunity areas for ecosystem protection and forestry resources. ATXI has coordinated on the route through the Apple Creek Conservation Area and will continue to coordinate with the MDC and obtain any required permits or approvals before construction.
State Parks	Missouri Department of Natural Resources (MDNR)	ATXI provided coordination letters. MDNR did attend the community forum. ATXI initiated a follow up call with the Regional office regarding the Limestone Ridge Project. ATXI will continue coordination and obtain required permits before construction.
Cultural Resources	Missouri Department of Natural Resource State Historic Preservation Office (SHPO)	ATXI initiated coordination with the SHPO on the Limestone Ridge Project regarding known historic resources. ATXI will continue coordination and obtain any necessary approvals before the construction.
Karst / Caves	Missouri Geological Survey (MGS)	ATXI coordinated with MGS regarding the karst and caves systems in the study area to better understand the geology and constraints associated with geology.
Agriculture	Missouri Department of Agriculture	ATXI provided consultation letters to the Department; no responses were received.
Soils and Erosion	Missouri Soil and Water Conservation District	ATXI provided consultation letters to the Department; no responses were received.
Highway improvements and crossing permits	Missouri Department of Transportation	ATXI provided coordination letters and completed follow up coordination to better understand improvements activities on Highway A crossed by the route. ATXI will obtain required highway crossing permits before construction.

Federal Threatened and Endangered Species	United Fish and Wildlife Service	ATXI initiated coordination with the USFWS and will initiate formal consultation once a route has been approved. ATXI will obtain any required approvals before the start of construction.
Waters of the United States	United State Army Corps of Engineers (USACE)	ATXI provided coordination letters and will continue to coordinate with USACE once potential impacts to waters of the United States are determined. Required permits before the start of construction.
Soils and Erosion and Conservation Easements	Natural Resources Conservation Service	ATXI provided consultation letters to the Department; no responses were received.
Farmland Easements	Farm Service Agency	ATXI provided consultation letters to the Department; no responses were received.
Tribal Coordination	Native American Tribes with Historic Interest in Perry and Cape Girardeau County	During the outreach activities, ATXI became aware of the potential to encounter sensitive resources. ATXI reached out to several Tribes to better understand the known resources in the area. ATXI will continue to coordinate with the interested Tribes.
