AMEREN MISSOURI’S COMMENTS TO RECOMMENDED REPORT AND ORDER

COMES NOW Union Electric Company d/b/a Ameren Missouri (the “Company”) and pursuant to 4 CSR 240-2.070(15)(H) respectfully submits the following limited comments to the Recommended Report and Order issued in this complaint on June 30, 2015.

1. Ameren Missouri supports the Conclusions of Law set forth in the *Recommended Report and Order*.

2. Ameren Missouri respectfully suggests that the Commission consider revising certain Findings of Fact set forth in the Recommended Report and Order, and certain citations to authority therein, as follows:

- a. At paragraph 2 of the Findings of Fact, changing the date April **14**, 2007, to April **17**, 2007, as reflected in the transcript testimony cited by the Regulatory Law Judge.
- b. At footnote 32 of the Findings of Fact, changing the references to the supporting exhibit from EFIS No. **71** and Exhibit **1HC**, to EFIS No. **72**, and Exhibit **2HC**—to reference the exhibit that pertains to the “present account.”
- c. At paragraph 9 of the Findings of Fact, changing the date September **28**, 2014, to September **8**, 2014, as reflected in Exhibit 5HC.
- d. At footnote 45 of the Findings of Fact, changing the reference made to Exhibit **5** to Exhibit **5HC**.
- e. At footnote 48 of the Conclusions of Law, changing the reference made to Section **393.360.1** RSMo 2000 to Section **386.390.1** RSMo 2000.

- f. At the concluding paragraph to Section C of the Conclusions of Law, on page 11, changing the wording:

or that he has not made any

to:

and he has not made any.

Wherefore, Ameren Missouri respectfully requests that the Commission consider these comments to the Recommended Report and Order.
