**STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and for its *Recommendation* respectfully states to the Missouri Public Service Commission ("Commission") the following:

1. On December 18, 2009, RDG Development, LLC ("Company") filed proposed tariff sheets for sewer service (YS-2010-0397) pursuant to the Commission's December 18, 2009 *Order Granting Certificate of Convenience and Necessity* ("Order"), bearing an effective date of January 17, 2009, and moved for the expedited approval of those tariff sheets to become effective January 1, 2010, as the Company filed them as soon as the Order was effective, and the Company is currently providing sewer service.

2. On December 21, 2009 the Company filed substitute tariff sheets bearing an effective date of January 17, 2010.

3. Jerry Scheible, Staff Utility Regulatory Engineer, reviewed the tariff sheets filed in Tracking No. YS-2010-0397, and states that to the best of his knowledge, information, and belief, the proposed sheets comply with the Commission's Order. See the *Affidavit Of Jerry Scheible, P.E.*, attached hereto.

4. The Commission has the authority pursuant to Sections 393.140 (11) and 393.150 RSMo (2000) to approve the proposed tariff sheets.

**WHEREFORE**, the Staff recommends that the Missouri Public Service Commission issue an Order approving the tariff sheets pending in Tracking No. YS-2010-0397, to become effective January 1, 2010.


