**STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and recommends that the Missouri Public Service Commission (“the Commission”) approve the tariffs submitted in Case No. SA-2010-0282; Tariff File No. YS-2011-0288. In support of this recommendation, Staff states as follows:

1. On December 6, 2010, Holtgrewe Farms Sewer Company, LLC (“Holtgrewe” or “the Company”) filed proposed tariff sheets pursuant to the Commission’s September 28, 2010 Order Granting Application for Certificate of Convenience and Necessity (“Order”). This filing created Tariff Tracking No. YS-2011-0288.

2. In its December 6, 2010 filing, the Company inadvertently submitted an incorrect version of tariffs that the Company had previously committed to file. These tariffs did not bear either an issue or an effective date.

3. On December 7, 2010, the Company, at the request of Staff, filed substitute tariffs, replacing the version incorrectly filed on December 6, 2010, with the version that should have been filed in compliance with the Commission’s Order. These tariffs were submitted bearing an issue date of December 2, 2010 and no effective date.

4. Later on December 7, 2010, an additional substitute tariff was filed as a result of Staff assisting the Company in inserting an effective date for the tariff filing.

5. The Commission has the authority to approve the proposed tariff sheets pursuant to Section 393.140(11), RSMo (2000).

6. Jim Merciel, Utility Regulatory Engineering Supervisor, reviewed the tariff sheets filed in Tracking No. YS-2011-0288, and states that to the best of his knowledge, information, and belief, the proposed sheets comply with the Commission's Order. *See Affidavit of James A. Merciel, Jr., P.E.*, attached hereto and incorporated by reference herein.

**WHEREFORE**, Staff recommends that the Commission issue an order approving the tariff sheets pending in Tariff Tracking No. YS-2011-0288, to become effective January 5, 2011.


