REQUEST FOR AMENDED ORDER

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and hereby submits this *Request for Amended Order*.

1. On April 17, 2019 the Commission issued its *Order Granting Certificate of Convenience and Necessity and Waiver* (“Order”), issuing a Certificate of Convenience and Necessity to United Services, Inc. (“United”).

2. Due to typographical errors, Staff’s recommendation memorandum, filed March 26, 2019, erroneously states on pages 5 and 10 that United’s monthly flat rate for commercial and Countryside subdivision customers is \$43.84.¹ This \$43.84 rate was incorporated in pages 3 and 4 of the Order.

3. The correct rate for these customers is \$42.84. United has not issued any billings with the \$43.84 rate, and the proposed tariff sheets, filed May 6, 2019 in YS-2019-0203, reflect the correct \$42.84 rate.²

4. Staff requests that the Commission issue an amended order correcting the rate for United's commercial and Countryside subdivision customers from \$43.84 to \$42.84. Counsel for United does not oppose this request.

WHEREFORE, Staff requests that the Commission issue an amended order reflecting the correct monthly flat rate of \$42.84 for United's commercial and Countryside subdivision customers.
