**STAFF RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and hereby submits this *Staff Recommendation for Approval of Tariff Sheets* in response to the Commission’s August 29, 2019 *Order Directing Filing*.

1. On July 10, 2019, the Commission issued a *Report and Order Granting Certificate of Convenience and Necessity and Waiver* approving issuance of a certificate of convenience and necessity for Missouri-American Water Company (“MAWC”) to provide sewer service to the Hillers Creek service area. In this order, the Commission directed MAWC to submit new and revised tariff sheets that include a service area map, a service area written description, and service rates.

2. MAWC filed two tariff revisions, with one set of substitute tariff sheets. MAWC filed Tariff Revision No. YS-2020-0026 on August 12, 2019. MAWC filed substitute tariff sheets in Tariff Revision No. YS-2020-0026 on August 26, 2019. MAWC filed Tariff Revision No. YS-2020-0037 on August 28, 2019.

3. On August 29, 2019, the Commission directed Staff to file a recommendation for Tariff Revision YS-2020-0026 by September 3, 2019, and a recommendation for Tariff Revision YS-2020-0037 by September 9, 2019. Staff files both recommendations in this pleading.

4. The tariff sheets filed comply with the Commission's July 10, 2019 order.

Therefore, Staff recommends approval of the following tariff sheets:
