**ORDER DIRECTING AN EXPEDITED STAFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On November 17, 2021, the Commission issued its order granting Missouri-American Water Company (MAWC) a certificate of convenience and necessity to acquire the sewer assets of the City of Hallsville, Missouri. On February 1, 2022, MAWC filed tariff sheets to comply with the Commission’s order together with a motion for expedited treatment. Those tariff sheets bear an effective date of March 3, 2022, but MAWC has requested that the Commission allow those tariff sheets to take effect on February 25, 2022. In consideration of MAWC’s request the Commission will direct its Staff to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any other responses to the tariff sheets or MAWC’s request for expedited treatment.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the tariff sheets and motion for expedited treatment filed by MAWC no later than February 14, 2022, at 3:00 p.m.

2. Any other responses to MAWC's tariff sheets or motion for expedited treatment shall be filed no later than February 14, 2022, at 3:00 p.m.

3. This order is effective when issued.
