**ORDER APPROVING TARIFF AND GRANTING MOTION
FOR EXPEDITED TREATMENT**

Issue Date: February 17, 2022

Effective Date: February 25, 2022

On November 17, 2021, the Commission issued its Report and Order granting Missouri-American Water Company (MAWC) a certificate of convenience and necessity (CCN) to acquire and operate the City of Hallsville's water system. The Commission's order directed MAWC to file tariff sheets conforming to the Commission's order prior to closing on the assets. On February 1, 2022, MAWC filed tariff sheets to comply with the Commission's order along with a motion for expedited treatment. MAWC's motion for expedited treatment asks the Commission to allow its compliance tariff sheets to take effect on February 25, 2022, prior to the tariff sheets' effective date of March 3, 2022. The Commission directed its Staff (Staff) to file a recommendation about the compliance tariff sheets and motion for expedited treatment, and set a deadline for any responses to MAWC's motion for expedited treatment of compliance tariff sheets. Staff filed a statement advising that the tariff sheets comply with the Commission's order. No other responses were received.

MAWC's compliance tariff sheets bear an effective date of March 3, 2022, but MAWC's motion for expedited treatment asks the Commission to approve the compliance tariff sheets to take effect on February 25, 2022, prior to closing of the purchase of assets for the City of Hallsville.

The Commission has reviewed the compliance tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets to comply with the Commission's order granting MAWC a CCN. The Commission will approve MAWC's compliance tariff sheets to become effective on February 25, 2022. In addition, the Commission finds it reasonable under Section 386.490.2, RSMo, to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.

THE COMMISSION ORDERS THAT:

1. MAWC's motion for expedited treatment is granted.
2. The following tariff sheets filed by MAWC and assigned Tariff No.
