What was included in the Ordinance? 7 A. Section 1 of the *Ordinance* provided notice of an election to be held on November 5, 8 2019, to vote on Proposition 1, whether the wastewater utility owned by the City of 9 Hallsville should be sold. 1	A.	Yes. Hallsville held a meeting on October 3, 2019, two additional meetings were held
2		by MAWC.
3	Q.	Did you attend those meetings?
4	A.	I attended the meeting held by Hallsville, City officials were advised by, then City
5		Attorney, John Whiteside to not attend meetings held by MAWC.
6	Q.	Did Hallsville ultimately conduct an election?
7	A.	Yes. The election was held on November 5, 2019, and a majority of votes cast were in
8		favor of Proposition 1.
9	Q.	Did Hallsville subsequently negotiate a Purchase Agreement with MAWC?
10	A.	Yes. A Purchase Agreement was signed on July 14, 2020.
11		III. PUBLIC INTEREST
12	Q.	Do you believe that a sale of the Hallsville system to MAWC is in the public
13		interest?
14	A.	Yes. Municipal systems, such as the City of Hallsville, frequently lack funding to
15		address critical needs, such as the treatment process in this case.
16		Currently, the largest anticipated capital need is the addition of some type of
17		wastewater treatment. Hallsville's current practice of land applying 100% of the
18		wastewater effluent is not a long-term solution as Hallsville does not own the property
19		or the application equipment and is dependent upon local landowners/partners.
20		Hallsville is confident in MAWC's commitment to compliance and solving water and
21		wastewater challenges and therefore wants to sell this system to MAWC. I believe it
22		is in the public interest for MAWC to own and operate the system and provide service.
23	Q.	What do you ask the Missouri Public Service Commission to do in this case?
24	A.	Approve MAWC's Application.
