**ORDER APPROVING TARIFF AND GRANTING MOTION
FOR EXPEDITED TREATMENT**

Issue Date: October 19, 2022

Effective Date: November 1, 2022

On September 14, 2022, the Commission issued its order granting Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) a certificate of convenience and necessity to acquire and operate a sewer system in Madison County, Missouri. The Commission's order directed Confluence Rivers to file tariff sheets conforming to the Commission's order prior to closing on the assets. On October 10, 2022, Confluence Rivers filed tariff sheets to comply with the Commission's order along with a motion for expedited treatment. Confluence Rivers' compliance tariff sheets bear an effective date of November 9, 2022, but Confluence Rivers' motion for expedited treatment asks the Commission to approve the compliance tariff sheets to take effect on November 1, 2022, prior to closing of the purchase of assets for Deer Run. The closing on assets is currently scheduled for the first week of November 2022.

The Commission directed its Staff (Staff) to file a recommendation about the compliance tariff sheets, and set a deadline for any responses to Confluence Rivers'

compliance tariff sheets. Staff filed a statement advising that the tariff sheets comply with the Commission's order. No other responses were received.

The Commission has reviewed the compliance tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets to conform to Confluence Rivers' expected closing on assets. The Commission will approve Confluence Rivers' compliance tariff sheets to become effective November 1, 2022. In addition, the Commission finds it reasonable under Section 386.490.2, RSMo, to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.

THE COMMISSION ORDERS THAT:

1. Confluence Rivers' motion for expedited treatment is granted.
2. The following tariff sheets filed by Confluence Rivers and assigned Tracking No. YS-2023-0066, are approved to become effective on November 1, 2022:
