ORDER SHORTENING TIME FOR RESPONSES

On October 10, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed tariff sheets to comply with the Commission's *Order Granting Certificate of Convenience and Necessity*. Those tariff sheets, Tracking No. YS-2023-0066, have an effective date of November 9, 2022. Confluence Rivers also filed a *Motion for Expedited Treatment*, stating that Deer Run, which is transferring its sewer assets, is prepared to close the approved transaction during the first week of November. Thus, Confluence Rivers requests the tariff sheets go into effect on less than 30 days' notice and become effective on November 1, 2022.

The Commission will shorten the time for responses to the tariff sheets and to the motion for expedited treatment. The Commission will also direct the Staff of the Commission (Staff) to file a recommendation regarding the tariff sheets.

THE COMMISSION ORDERS THAT:

1. Any responses to the tariff sheets, Tracking No. YW-2023-0066, or the request for expedited treatment shall be filed no later than 12:00 p.m., October 17, 2022.
2. Staff shall file a recommendation regarding the tariff sheets no later than 12:00 p.m., October 17, 2022.

3. This order is effective when issued.
