**ORDER GRANTING EXTENSION TO RESPOND  
TO STAFF’S RECOMMENDATION FILED ON JUNE 5**

On January 4, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of an unpermitted sewer system. The Staff of the Commission (Staff) filed its updated recommendation on June 5, 2023.

Confluence Rivers requested an extension of the Commission’s standard 10-day deadline for it to file a response. Confluence Rivers indicated it had a concern with a certain Staff recommendation and needed until June 22, 2023 to respond.

The Commission finds the request reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Confluence Rivers’ request for an extension of time is granted. Confluence Rivers and the Receiver shall file its response to the Staff recommendation, or another appropriate pleading, on or before June 22, 2023.
2. This order shall be effective when issued.
