**ORDER DIRECTING NOTICE, SETTING DEADLINE FOR  
INTERVENTION REQUESTS, AND DIRECTING FILING OF  
STAFF RECOMMENDATION**

On January 4, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence) filed an application to acquire an unpermitted sewer system assets, and for a certificate of convenience and necessity (CCN) to operate the system and provide service to the public. The Staff of the Commission (Staff) was directed to file its recommendation or a request for an extension of time by February 28, 2023.

Staff timely requested an extension of time, and in support thereof stated that Staff is in ongoing communications with Confluence regarding the land involved and a correct legal description of the land. Staff stated it expects to be able to file a recommendation no later than April 14, 2023.

The Commission allowed time for responses, but no responses or objections to Staff's request were received.<sup>1</sup> The Commission finds the unopposed request reasonable and will grant it.
