ORDER CONSOLIDATING CASES AND SETTING PREHEARING CONFERENCE

The Commission has reviewed the above captioned complaints, the answers and its Staff's recommendation on consolidation. No party filed a response to Staff's recommendation, and the Commission finds these actions involve related questions of law and fact. Pursuant to Commission Rule 4 CSR 240-2.110(3) the Commission will consolidate these actions. The Commission shall also set a procedural conference to further the resolution of these matters.

THE COMMISSION ORDERS THAT:

1. File numbers SC-2010-0150, WC-2010-0151, SC-2010-0152 and WC-2010-0153 are consolidated. File No. SC-2010-0150 is designated as the lead case.
2. The parties shall appear at a procedural conference to be held on Wednesday, January 20, 2010, beginning at 10:00 a.m. The procedural conference will be held in Room 305 at the Commission's offices in the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This building meets the accessibility standards required by the Americans With Disabilities Act.
