#### STATUS REPORT AND JOINT PROCEDURAL SCHEDULE

COME NOW the Staff of the Missouri Public Service Commission ("Staff"), the Office of Public Counsel ("OPC") and Aqua Missouri, Inc.<sup>1</sup> (collectively referred to hereinafter as "the Parties") and submit their <u>Status Report and Joint Procedural Schedule</u> ("<u>Joint Procedural</u> Schedule") as follows:

- 1. On the January 20, 2010, the Missouri Public Service Commission ("the Commission") issued its <u>Order Directing Status Report</u> ("<u>Order</u>"), directing the Parties to file by January 27, 2010 a status report in the manner described at the January 20, 2010 prehearing conference.
- 2. On January 22, 2010, the Parties filed their <u>Joint Motion for Extension of Time to</u>

  <u>File Status Report and Request for Reservation of Evidentiary Hearing Dates</u> ("<u>Motion</u>"),
  requesting that the Commission issue an order (1) extending the date by which the Parties must
  file the status report as described at the January 20, 2010 prehearing conference and (2) reserving

April 14 - 16, 2010 as the dates for the evidentiary hearing in this matter should such hearing be necessary at that time.

- 3. On January 25, 2010, the Commission issued its <u>Order Granting Motion for Extension of Time to File Status Report</u> ("<u>Extension</u>"), extending until February 5, 2010, the deadline for the filing of the status report as directed by the Commission at the January 20, 2010 prehearing conference.
- 4. In response to the Commission's <u>Order</u> and <u>Extension</u> the Parties hereby propose the following procedural schedule:

Parties to File Post-Hearing Briefs - May 7, 2010

Parties to File Reply Briefs - May 14, 2010
