## STATUS UPDATE IN RESPONSE TO ORDER DIRECTING FILING

Comes now Dialaround Enterprises Inc. ("Dialaround") and STi Prepaid, LLC ("STi Prepaid"), by and through counsel, and in response to the Commission's Order Directing Filing issued on September 19, 2007, state:

- 1) STi Prepaid and Dialaround have not yet completed the transfer of assets authorized by this Commission in its Order dated June 5, 2007 because the companies are still awaiting regulatory approval of the transaction from the State of Arizona. All other states have given regulatory approval to the transfer of assets.
- 2) STi Prepaid and Dialaround anticipate obtaining regulatory approval from the State of Arizona by the end of June, 2010 but will advise the Commission as soon as the approval is received.
- 3) If the final approval is not received by June 30, 2010, STi Prepaid and Dialaround will give the Commission a further status report at that time pursuant to the Commission's Order dated September 19, 2007.
