While KCP&L and GMO filed Direct Testimony in File No. EO-2012-0367 (KCP&L and GMO’s Transfer Application), and Transource Missouri filed Direct Testimony in File No. EA-2013-0098 (Transource Missouri’s Certificate of Convenience and Necessity Application), the Consolidation Order consolidated those files and all subsequent testimony was

filed only in File No. EA-2013-0098, including the Applicants' Surrebuttal Testimony. Thus, the Applicants' Exhibit List, attached hereto as Attachment 1, designates all testimony as "Transource Exhibit No. 1," etc., as specified in the Consolidation Order at 7 and Order Directing Filing at 1.
