## REPORT OF RIVERSIDE COLLABORATIVE GROUP

Comes now the City of Riverside, Missouri ("Riverside"), and on behalf of the Riverside Collaborative Group (the "Collaborative Group"), states to the Missouri Public Service Commission (the "Commission") as follows:

1. On June 16, 2010, the Commission issued its Report and Order in the above-referenced matter which, among other things, approved a Stipulation and Agreement entered into by a number of the Parties. One of the provisions of that Stipulation and Agreement involved the agreement to establish a Collaborative Group to study the need, procedure and options to address the concerns expressed in Riverside's testimony. Specifically, paragraph 14 of the Stipulation and Agreement stated:

**City of Riverside**. MAWC, Riverside, Staff and Public Counsel shall form a task force to further investigate the service concerns expressed in Riverside's testimony. If the parties to the task force cannot agree on infrastructure plan provisions by November 1, 2010, then they will bring their unresolved issues to the Commission for adjudication.

2. Beginning in July, 2010, representatives of the Staff of the Commission, Missouri-American Water Company, Riverside and Office of the Public Counsel began a series of meetings to discuss the need, procedure and options to address the concerns expressed in Riverside's testimony. Riverside's counsel is confirming the information provided by Missouri-American Water Company and reviewing Riverside's current options to address the concerns raised in its testimony. The Collaborative Group requests additional time to establish whether Riverside's concerns can be or have been resolved.

3. Parties involved in this Collaborative Group agree to continue discussions on these topics and request that they be allowed to provide a status update to the Commission regarding any progress made in this effort by February 23, 2011.

Wherefore, the Collaborative Group requests the Commission to allow the parties to provide a status update to the Commission regarding any progress made in this effort by February 23, 2011.
