FIRST AMENDED ORDER DIRECTING NOTICE AND SETTING DEADLINE FOR INTERVENTION

On September 17, 2020, Missouri-American Water Company (MAWC) filed its application for a certificate of convenience and necessity (CCN) and waiver. The Company applied for a CNN authorizing it to install, own, acquire, construct, operate, control, manage, and maintain sewer systems in and around the City of Trimble, Missouri (application) On September 18, 2020, the Commission issued its Order directing Notice, Setting Date for Intervention and Ordering Staff recommendation. On December 3, 2020, the Commission Staff (Staff) filed its Recommendation to Grant Certificate of Convenience and Necessity (recommendation).

In its application, MAWC requested authorization to serve two territories: the City of Trimble and another area called Centennial Acres, which is a residential development of single family lots located near Trimble, Missouri. Staff's recommendation states that during their consideration of the application, Staff and MAWC worked together to develop a proposed service area that is expanded from that requested in the application. The proposed expanded service area map is shown in Attachment A to Staff's recommendation, and the modified written description is shown in Attachment B of Staff's recommendation. Attachments A and B are attached as such to this Order. The proposed modified service area includes, but also expands upon, the territory proposed in the application. Staff recommends that a CCN be approved for the service area shown and described in Attachments A and B and that this service area be depicted in MAWC's tariff.

Because the areas shown in Attachment A and described in Attachment B were not designated in the application as the territory initially proposed for a certificate of convenience and necessity, the Commission will issue a First Amended Order Directing Notice and Setting Date for Intervention.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall send notice of the application together with this order and Attachments A and B mentioned in the body of this order to the members of the media and the General Assembly representing Clinton County, Missouri.

2. The Commission's Data Center shall provide a copy of this order together with Attachments A and B mentioned in the body of this order to the county commission of Clinton County, Missouri, and to the Missouri Department of Natural Resources.

3. Any request to intervene shall be filed with the Commission no later than January 29, 2021. Such applications shall be filed with the Commission's electronic filing and information service, or:
