ORDER DIRECTING NOTICE AND ESTABLISHING TIME FOR FILINGS

Issue Date: August 12, 2021 Effective Date: August 12, 2021

On August 4, 2021, Mid Mo Sanitation, LLC (Mid Mo) filed an Application and Motion for Waiver (Application) requesting a line certificate of convenience and necessity to own, operate, maintain, control, and manage a sewer system in Callaway County, Missouri. The Application states because of a compliance schedule issued by the Missouri Department of Natural Resources ("MDNR") requiring Mid Mo to design and build a system that would remove ammonia from wastewater before it may be discharged to the waters of the state, Mid Mo has constructed and placed in service a system whose equipment is located and effluent is applied on land outside of the territory of Mid Mo's area certificate. The Application requests a line certificate. The Application states that there is a single owner of the real estate for which the certificate is sought, but that no one resides there. The Application states that the area Mid Mo proposes to certificate is critical to Mid Mo's ability to operate its MDNR compliant and permitted sewer system.

The application seeks a waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(1) (D).

The Commission will direct notice be given and set deadlines for intervention applications and responses. The Commission will also direct the Commission Staff to file a recommendation with regard to Mid Mo's application.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall provide a copy of this Order and Mid Mo's application to the county commission of Callaway County, Missouri.
- 2. The Commission's Public Policy and Outreach Department shall provide notice of Mid Mo's application to the members of the General Assembly representing residents of Callaway County, as well as to the news media serving residents of Callaway County.
- 3. Applications for intervention shall be filed no later than September 11, 2021. Any such filing shall be submitted through the Commission's electronic filing and information system or delivered to:

- 4. No later than September 11, 2021, the Commission's Staff shall file either a recommendation regarding Mid Mo's application or a status report indicating when it expects to file a recommendation.

APPLICATION AND MOTION FOR WAIVER

COMES NOW Mid Mo Sanitation LLC. (Mid Mo), pursuant to Sections 393.170.1, RSMo. (line certificate), 20 CSR 4240-2.060, 20 CSR 4240-3.305 and 20 CSR 4240-4.017, and for its *Application and Motion for Waiver*, states as follows to the Missouri Public Service Commission (Commission):

BACKGROUND

- 1. This Application is being filed by Mid Mo to obtain from the Commission a certificate of convenience and necessity to own, operate, maintain, control and manage a sewer system (line certificate) in Callaway County, Missouri.
- 2. Mid Mo is a Missouri limited liability company duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 1101 Sioux Drive, Fulton, MO 65251. Attached hereto as **Appendix 1** is a Certificate of Good Standing issued by the Missouri Secretary of State related to Mid Mo. Mid Mo has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates having occurred within three years from the date of this Application. Mid Mo has no annual report or assessment fees which are currently overdue.

- 3. Mid Mo provides sewer service to approximately 28 customers in Callaway County, Missouri, pursuant to a certificate of convenience and necessity previously granted in Commission File No. SA-2009-0319. Mid Mo is a "sewer corporation" and a "public utility," as those terms are defined in Section 386.020, RSMo, and is subject to the jurisdiction and supervision of the Commission as provided by law.

CERTIFICATE

- 5. On February 1, 2015, the Missouri Department of Natural Resources (MDNR) issued a new wastewater discharge permit for Lake Breeze Estates, which is served by Mid MO. That permit established a compliance schedule requiring Mid MO to design and build a suitable system that would remove nearly all ammonia from the wastewater before being allowed to be discharged to the Waters of the State. An Engineering Facility Plan was prepared and submitted to MDNR. The Plan examined various treatment options. The best, most affordable option was a "no discharge land application system." That option has since been approved, constructed and placed into service.
- 6. The area used for land application is outside the territory of Mid Mo's area certificate where it provides service to the public. Accordingly, seeks this line certificate for the area where the application equipment is located, and effluent is applied.

- 7. The line certificate requested is in the area in Callaway, Missouri, as set forth on the map attached to this Application as **Appendix 2** (20 CSR 4240-3.3.305(A).4). A legal description of the area to be certificated is attached hereto as **Appendix 3** (20 CSR 4240-3.3.305(A).3).
- 8. No other sewer service is currently available in this area (20 CSR 4240-3.3.305(A).1), nor does Mid Mo seek to provide sewer service in this area.
- 9. There is a single owner of the real estate (and no residents) that constitutes the area for which a certificate is sought (20 CSR 4240-3.3.305(A).2). Attached hereto as **Appendix 4** is a document identifying that owner.
- 10. Plans and specifications for the application system and cost of the construction of the system have been provided to the Staff of the Commission in File No. SR-2021-0372. No financing has been required to construct the application system. There are no proposed rates or customers in the area to be certificated. Revenues and expenses during the next three (3) years of operation are currently the subject of Commission Case File No. SR-2021-0372. (20 CSR 4240-3.3.305(A).5).
- 11. Mid Mo not aware of any franchise (either city or county) that would be required in order for it to conduct the land application in this area. Mid Mo's system is permitted by the MDNR and meets all requirements of the MDNR. Mid Mo is not aware of any other governmental approval that it must obtain. (20 CSR 4240-3.305(B)).
- 12. The area Mid Mo proposes to certificate is critical for Mid Mo to operate its MDNR compliant and permitted sewer system. A grant of the application will further the public convenience and necessity. (20 CSR 4240-3.305(D)).

MOTION FOR WAIVER

- 13. Commission Rule 20 CSR 4240-4.017(1) requires "[a]ny person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case." Because it did not file such a notice within the time period prescribed by that rule, Mid Mo seeks a waiver of the 60-day pre-filing notice requirement.
- 14. Under Rule 20 CSR 4240-4.017(1)(D), a waiver of the pre-filing notice requirement may be granted for good cause. In this regard, Mid Mo declares, as verified below, that it has had no communication with the Office of the Commission (as defined in 20 CSR 4240-4.015(10)) within the prior 150 days regarding any substantive issue likely to be in this case. Good cause for the requested waiver exists in accordance with Commission Rule 20 CSR 4240-4.017(1)(D) ("Good cause for waiver may include, among other things, a verified declaration from the filing party that it has had no communication with the office of the commission within the prior one hundred fifty (150) days regarding any substantive issue likely to be in the case...."
- 15. Therefore, as authorized by Rule 20 CSR 4240-4.017(1)(D), Mid Mo moves for a waiver of the 60-day notice requirement and acceptance of this application at this time.

WHEREFORE, for the reasons previously stated, Mid Mo respectfully requests the Commission issue an order:

- (A) Waiving the 60-day notice requirement of Rule 20 CSR 4240-4.017(1) for good cause shown; and,
- (B) Granting Mid Mo a CCN authorizing it to install, acquire, build, construct, own, operate, control, manage, and maintain a sewer system (line certificate) for the public within the

area identified herein.


