# ORDER GRANTING EXTENSION TO RESPOND TO STAFF RECOMMENDATION

On January 4, 2023, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of an unpermitted sewer system. The Staff of the Commission (Staff) filed its recommendation on April 6, 2023.

Confluence Rivers and the Receiver have jointly requested an extension of the Commission's standard 10-day response deadline. Confluence Rivers also indicated its intent to amend its application.

The Commission finds the request reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

- 1. Confluence Rivers' and the Receiver's request for an extension of time is granted. Confluence Rivers and the Receiver shall file its response to the Staff recommendation, an amended application, or a request for further extension, on or before May 1, 2023.
