1. The Commission's Order Directing Filing, which was issued on September 1, 2010, directed the parties to advise the Commission whether they still wished to hold a hearing in this case on September 8-9, 2010. The Commission ordered the parties to respond no later than September 3, 2010.

2. The parties are currently discussing a stipulation and AmerenUE expects said stipulation to be agreed upon. However, because the stipulation has not been finalized, AmerenUE suggests that the Commission leave the hearing on its schedule for the time being.
