**APPLICATION TO INTERVENE FOR CITIES OF
WARRENSBURG, O'FALLON AND WELDON SPRING**

Come now the Cities of Warrensburg, O'Fallon and Weldon Spring, pursuant to 4CSR 240-2.060 and for its Application to Intervene states to the Commission:

1. The City of Warrensburg, Missouri, is a third class municipality situated in Johnson County, Missouri. The City Hall is located at 102 S. Holden, Warrensburg, Missouri 64093. The City receives water service from Missouri-American Water Company ("MAWC").

2. The City of O'Fallon, Missouri, is a fourth class municipality situated in St. Charles County, Missouri. The City Hall is located at 100 North Main Street, O'Fallon, Missouri 63366. The City receives water from MAWC.

3. The City of Weldon Spring, Missouri, is a fourth class municipality situated in St. Charles County, Missouri. The City Hall is located at 711 Nancy Lane, Weldon Spring, Missouri 63304. The City receives water from MAWC.

5. On October 15, 1999, Missouri-American Water Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for water and sewer service provided to customers in the Missouri service area of the Company. The proposed tariffs bear a requested effective date of November 15, 1999. The proposed water service tariffs are designed to produce an annual increase of approximately 53.97 percent (\$16,446,277) in the Company's revenues. The proposed sewer service tariffs are designed to produce an annual increase of approximately 5.0 percent (\$2,363) in the Company's revenues.

6. On October 28, 1999, the Commission issued its Suspension Order and Notice setting a date for interested parties to intervene no later than November 17, 1999.


7. The Cities of Warrensburg, O'Fallon and Weldon Spring seek to intervene in this rate case proceeding because MAWC proposed to allocate its general rate increase on a Single Tariff Pricing ("STP") basis. The Cities oppose the STP methodology and support District Specific Pricing ("DSP").

8. The Cities interests are different from those of the general public.

WHEREFORE, the Cities of Warrensburg, O'Fallon and Weldon Spring, respectfully request the Commission to grant its Application to Intervene.
