**STAFF’S COMPLIANCE TARIFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission, through counsel, and submits this *Staff’s Compliance Tariff Recommendation*.

1. On September 11, 2019 the Commission issued its *Order Granting Certificate of Convenience and Necessity* in this case. This Order directs Timber Creek Sewer Company to file its 1st Revised Sheets 2A and 3A within 10 days after the Order’s effective date of October 11, 2019.

2. Timber Creek filed its 1st Revised Sheets 2A and 3A on October 14, 2019.

3. On October 15, 2019, the Commission directed Staff to file a recommendation by October 30, 2019, as to whether the tariff sheets comply with its Order.

4. Timber Creek filed substitute tariff sheets on October 18, 2019. These substitute tariff sheets accomplished two tariff improvements: a) usefulness of the Clay County service area map and b) legal description for this CCN service area.

5. Staff has reviewed the revised and substituted tariff sheets and concludes that the substitute tariff sheets filed on October 15, 2019, comply with the Commission’s September 11, 2019, *Order*. Thus, Staff recommends approval of:

**WHEREFORE**, Staff prays that the Commission will accept Staff's *Recommendation*, and issue an order approving Timber Creek's proposed tariff sheets as filed October 15, 2019, allowing them to take effect November 13, 2019; and grant such other and further relief as the Commission deems just in the circumstances.
