2. Axon proposes to own, operate, control and manage facilities used to provide telecommunications service throughout the state of Missouri. As a result, Axon would be defined as a "telecommunications company" under Section 386.020(42). Axon's principal service will be

the provision of dark fiber facilities for lease by other telecommunications companies. Rates are developed on an individual case basis. Axon will not provide retail services directly to consumers.

- 3. Axon's tariff which contains the rules and regulations applicable to its customers, a description of the services offered, and a list of rates associated with such services, is being simultaneously filed with the Commission and has a forty-five (45) day effective date.
- 4. Axon requests classification as a competitive intrastate interexchange telecommunications company operating within the state of Missouri. Axon further requests classification of services described in Axon's tariff as competitive services.
- 5. Applicant will not unjustly discriminate among its customers, which discrimination is prohibited pursuant to Section 392.200.
- 6. Applicant, pursuant to Section 386.570, will comply with all applicable Commission rules except those which are specifically waived by the Commission pursuant to a request filed by the Applicant.
- 7. Axon also respectfully requests, pursuant to Section 392.420, RSMo (Cum. Supp. 1990), that the Commission suspend, waive or modify the application of the following rules and statutory provisions as they relate to the regulation of the Applicant:


