**NOTICE OF APPLICATION AND ORDER DIRECTING FILING**

The Commission is directing issuance of notice of the application.<sup>1</sup> The application asks the Commission for authorization to provide sewer service to Branson Cedars Resort, on State Highway 86, in Taney County. The Commission is also setting the time for filing motions to intervene and a recommendation. The statutory requirement of a "due hearing"<sup>2</sup> allows the Commission to grant an unopposed application without conducting a hearing.<sup>3</sup>

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall serve this notice and order on the Commissioners of the Taney County Commission, and the persons listed in appendix 4 of the application.
2. The Commission's information officer shall make this notice and order available to the members of the Missouri General Assembly whose districts include the proposed service area, and media serving the proposed service area.

3. Any motion for intervention is due no later than December 3, 2014. Any person filing such a motion shall send the motion to:

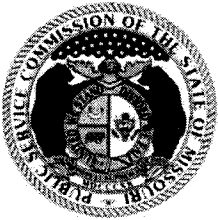




