## ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION

Issue Date: November 9, 2017 Effective Date: November 9, 2017

On November 9, 2017, Missouri-American Water Company ("MAWC") filed tariff sheets to reflect changes based upon Commission approval of a Certificate of Convenience and Necessity allowing MAWC to purchase and operate a sewer system in the Homestead Estates subdivision in St. Louis County, Missouri. The tariff sheets bear an effective date of December 9, 2017.

MAWC also filed a *Motion for Expedited Treatment* on November 9, 2017, requesting that the tariff take effect with less than thirty days notice. In support of its motion MAWC states that the subject of the Commission approved transactions will close on November 15, 2017. Therefore MAWC is asking for the proposed tariff sheets (YS-2018-0059) to be effective November 15, 2017, or as soon as the Commission has an opportunity to address the matter.

In consideration of the November 15, 2017, transaction date, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on

an expedited schedule. The Commission will also establish a deadline for any other entity to file a response to the tariff sheets or Staff's recommendation.

#### THE COMMISSION ORDERS THAT:

- No later than November 13, 2017, the Staff of the Missouri Public Service
   Commission shall file a recommendation with regard to the tariff sheets filed by
   Missouri-American Water Company.
- 2. Any other entity wanting to comment on the tariff sheets or Staff's recommendation shall do so no later than November 14, 2017.
  - 3. This order shall be effective when issued.
