ORDER DIRECTING CUSTOMER NOTICE

On May 1, 2018, Elm Hills Utility Operating Company, Inc. (“Elm Hills”) filed an application with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it a Certificate of Convenience and Necessity to provide sewer service to existing developments known as Rainbow Acres and Twin Oaks in Johnson County, Missouri. The Commission issued an order directing notice that also required Elm Hills to file suggestions on how to provide notice to the customers affected by the proposed transaction.

On May 14, 2018, Elm Hills filed a timely response to the order, suggesting that it prepare a notice, with the involvement of Staff and the Office of the Public Counsel, and mail that notice to all properties currently being served by the Rainbow Acres Homeowners Association and/or The Preserve Homeowners Association (for the Twin Oaks area). Ten days have elapsed, and no party has objected to the Elm Hills response.¹ The Commission finds the Elm Hills suggestion to be reasonable and will adopt it.

¹ Commission rule 4 CSR 240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

THE COMMISSION ORDERS THAT:

1. No later than June 8, 2018, Elm Hills Utility Operating Company, Inc. shall provide notice to all properties currently being served by the Rainbow Acres Homeowners Association and/or The Preserve Homeowners Association (for the Twin Oaks area) as described in its response filed on May 14, 2018.
2. This order shall become effective when issued.
