On May 1, 2018, Elm Hills Utility Operating Company, Inc. ("Elm Hills") filed an application with the Missouri Public Service Commission ("Commission") requesting that the Commission grant it a Certificate of Convenience and Necessity to provide sewer service to existing developments known as Rainbow Acres and Twin Oaks in Johnson County, Missouri. On July 30, 2018, the Staff of the Commission filed a recommendation to approve the application subject to several conditions. On August 1, 2018, the Commission directed Elm Hills to file a response addressing the conditions in the Staff recommendation and provided an opportunity for any other party to object or comment on the proposed conditions. The Office of the Public Counsel ("OPC") filed a response on August 10, 2018, but Elm Hills did not respond. The Commission will again direct Elm Hills to address the conditions proposed by Staff and by OPC.

THE COMMISSION ORDERS THAT:

1. Elm Hills Utility Operating Company, Inc. shall respond to the Staff recommendation and the filing by the Office of the Public Counsel, specifically addressing the proposed conditions set out in those pleadings, no later than August 20, 2018.

2. This order shall become effective when issued.
