SETTING A TIME FOR RESPONSES**

On July 23, 2021, the Commission directed its Staff (Staff) to file a pleading stating the date that Staff would be able to file a recommendation on Elm Hills Utility Operating Company's (Elm Hills) application for a Certificate of Convenience and Necessity (CCN). Staff states that it can file a recommendation by September 20, 2021. The Commission will direct Staff to file a recommendation by that date.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on Elm Hills' CCN application no later than September 20, 2021.
2. Any responses to Staff's recommendation or Elm Hills' application are due no later than September 30, 2021.
3. This order is effective when issued.
