ORDER APPROVING TARIFFS

Issue Date: July 16, 2021

Effective Date: July 30, 2021

On June 2, 2021, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, authorizing Missouri-American Water Company (MAWC) to install, own, acquire, construct, operate, manage, and maintain a sewer system in and around Taos, Missouri, in the area served by the City of Taos, Missouri.

On June 30, 2021, MAWC filed tariff sheets, assigned Tariff No. JS-2021-0267. The tariff sheets bear a proposed effective date of July 30, 2021.

On July 12, 2021, the Staff of the Commission recommended that the Commission approve the proposed tariffs. No party has filed a response to Staff's recommendation.¹ The Commission has reviewed the tariff filing and Staff's recommendation and concludes the tariff sheets should be approved in compliance with the Commission's June 2, 2021 order. To approve the tariff sheets to take effect on the requested date, this order will be effective on July 30, 2021.

¹ Commission Rule 20 CSR 4240-2.080(13) allows parties 10 days to respond to pleadings unless otherwise ordered by the Commission. The Commission's July 1, 2021 order directed any response to Staff's recommendation to be filed no later than July 15, 2021.
